Ethics Code: I will strive for professional excellence through ongoing assessment of personal strengths, limitations & effectiveness. I am fully committed to personal integrity, authenticity and my own ongoing healing and wholesome development in the mind, body & spirit. Conduct business and professional activities with integrity, in a professional, honest and fair manner. Abide by applicable local, state and national laws governing their health care systems. Perform only those services for which I am qualified, representing my education, certifications, professional affiliation and other qualification accurately.
